MINUTES

Call to Order

Commissioner Sobecki called the meeting to order at 02:05 PM. Commissioners Sobecki, Gerken, and Lopez were present.

County Engineer

Mike Pniewski was present and offered the following for approval:

1. - View of Big Coolie Ditch Improvement Project, Petition #1095

Commissioner Sobecki opened the hearing at 2:05 p.m.; Commissioners Sobecki, Gerken, and Lopez were present. Commissioner Sobecki stated that the legal notice for the hearing was published in the Toledo Legal News on January 21, 2025 and January 28, 2025.

Mike Pniewski, Lucas County Engineer, was present and provided the attached presentation of the location and condition of the proposed ditch petition project. Mr. Pniewski stated that the area has been granted funding for a ditch improvement project by the Ohio Department of Agriculture through the H2Ohio program and will be a self-forming or two-stage ditch improvement. A petition is required by ODOA to place the improvement under permanent maintenance once completed. Notice of the View and First Hearing was provided to the adjacent property owners in accordance with the Ohio Revised Code.
