Call to Order

Commissioner Sobecki called the hearing to order at 2:00 PM. Commissioners Lopez, Jeff Rupp, Joe Short, Jon Rupp, Lori Siclair, Robert Hastedt, and Glenn Miller were present; Commissioner Gerken was absent.

Hearing

Commissioner Sobecki opened the hearing and stated the purpose - This is the final hearing for the Swan Creek Watershed Petition Number 1054. The legal notice for this hearing was published in the Toledo News on July 16 and 23 of 2024, per the requirements of the Ohio Revised Code 6131.16. Lucas County Engineer Mike Pniewski sent a letter to the Board on July 25 detailing his request to recess and continue the final hearing on the Swan Creek Ditch Petition until July of next year. He is also requesting to remove the length of Swan Creek, Fullers Creek, and Nevis Ditch within Fulton County from the petition. This recommendation is based on feedback from members of the public and our offices have received calls and emails, and we thank you for those, and we have listened to you as we consider the engineers' request to recess and continue this final hearing to 2025.
